Summer Term Meeting 2023 Local Governing Board; Coads Green School Monday 19th June 2023, 5.30pm, at Coads Green School

1. Welcome and Apologies

2. Declarations of Interest Relevant to this Agenda

None relevant to this agenda.

3. Governor Resignation and New Appointment

Oliver Stephens resigned on 16/3/23 due to moving to another school within the Trust. Hayley Howard was appointed as the new Staff Governor for a 4-year term until 19/06/2027. Hayley Budge's term of office ends 2/12/23. As HB is now a member of staff, she will no longer be eligible to continue as a Parent Governor for another term. CB will look for a new parent governor before the end of HB's term.

4. Confirm Minutes of LGB Spring Meeting (27th February 2023) and Matters Arising

The Minutes of the Spring Meeting were agreed as a true and accurate record and the Chair signed a copy.

6. **Headteacher Report**

The Head's report has been made available to all governors. Key points were raised. Who will be taking the lead on Maths now that OS has left? OS did a deep-dive and this will form part of staff reviews but a new lead has yet to be decided. After discussion, the governors were happy with the Head's report and raised no further questions.

7. Improvement Plan & Data Analysis

The latest data was provided to governors is in the Head's report CB has met with the CEO who is happy with attainment and progress.

All Trust schools need to be right-respecting schools, which should tie in with the Trust Improvement Plan.

8. Curriculum

This includes extra-curricular provision – athletics and cricket are taking place this term, plus after school club and breakfast club.

The curriculum will include reading & phonics, sustainability and climate change

A bid has been submitted to Awards for All which will hopefully fund improving the garden. MM will also put a bid in to Tesco.

The Head assured the governors that information about the curriculum is published on the school website and that the website is compliant.

9. Safeguarding

S157 has been submitted to the LA. No issues to report.

11. Staff Matters

- Views of Staff (survey/feedback) CB has collated all the surveys and reviews; the staff review was overwhelmingly positive.
- Monitor welfare & workload, and work/life balance—CB ensures staff have a good work/life balance
- Skills & Training will anyone need to have training for the Maths Lead? Hopefully not, as all staff, including TAs, are already involved and everything is covered. RW Inc is being followed and it is hoped more RW Inc resources will be introduced in September. TAs are also involved with this.

The GDPR review has taken place. Health &Safety checks are all up to date.

CB will review the Exception Report.

13. Governor Monitoring & Training

It was confirmed that the second Open Day took place on 16th May.

The Big Picture is taking place at Launceston Town Hall on 4th/5th July. CB will be organising the Coads Green exhibition.

 - The implementation of the Literacy Tree is having an impact and staff have been positive about this programme
 - o Some pupils would benefit from some interventions in the autumn term
 - Spelling is the priority.
- VL and Pupil Conferencing has been cancelled for the time being
